

## **Consignment Terms and Conditions**

**Horse catalog deadline-September 17, 2010**

**All entries must include a photo for the catalog**

**Catalog Entry Fee \$100.00.**

**10% commission charged to the seller for all animals sold.**

**Pass-out fee \$100.00**

**All checks will be mailed five working days after the sale.**

**Do not bring us an unsound horse or mule. Our goal is to provide a quality sale for both the consignors and buyers. Unsound animals will not be allowed in the sale, so please leave them home. In addition, do not misrepresent the age of an animal. If you are in any way unsure of the age, have your vet mouth the animal prior to the sale.**

**If you have registered stock you must have the paperwork in order. All registration papers must be in the current owners name at the time you check the animal in at the auction. If your registration papers are not in order, the animal will be sold as a grade.**

**No entry fees will be refunded for any reason. If you have an animal which comes up lame or is sick before the sale you may substitute another in its place. You will keep your same spot in the catalog.**

**Please do not put for sale signs up in the barns advertising any animals not in the auction. It's not fair to the other consigners.**

**California law requires horse and mule consignors to provide a halter and lead rope for the buyer of their animal. It's also just the right thing to do.**

**The consignor of a horse or mule agrees that the sale management, auctioneer, or employees of the sale will not be held responsible for any accident that may occur to horses, mules, personnel, or persons attending the sale, or for loss of any kind to horses, mules or equipment through any cause, including fire, theft or injury. The consignor understands that the Tulare County Stockyard will provide stalls for animals, but that the consignor is responsible for their care, custody and control until delivered to a buyer, at which time he or she will assume responsibility.**
